## Call for Nominations

Fund for the Arts seeks nominations for the Cultural Advisory Council, a new advisory council which is responsible for providing feedback and guidance to the Fund for the Arts Community Impact Committee as it determines the strategic direction of Fund for the Arts grants and investments and fulfills its governance responsibilities.

### **What is the Purpose of the Cultural Advisory Council?**

The primary purposes of the Cultural Advisory Council include:

- Providing feedback on programs, processes, criteria, evaluation, and improvements for strategic initiatives, collective impact, and grant programs.
- Representing the interests and needs of the arts and culture sector as a whole, and the community at large, and under the framework of Imagine Greater Louisville 2020 and the strategic mission of the Fund for the Arts.
- Serving as a connector, communicator, and advocate of the Fund for the Arts to and from their respective stakeholders and partners.

### **Who may serve on the Cultural Advisory Council?**

The Cultural Advisory Council is comprised of representatives from:

- The Greater Louisville arts and culture sector.
  - Greater Louisville is defined as: Washington, Scott, Clark, Harrison, and Floyd counties in Indiana; and Jefferson, Oldham, Trimble, Henry, Shelby, Spencer, and Bullitt counties in Kentucky.
- Fund for the Arts community partners, such as the Arts & Culture Alliance, Imagine Greater Louisville 2020, out-of-school-time providers, and public and private school systems.
- Major grant programs of the Fund for the Arts, such as Sustaining Impact Grants, Imagine Greater Louisville 2020, ArtsMatch, Arts for Kosair Kids®, Cultural Pass, 5x5, Teacher Arts Grants, etc.

As a whole, the Cultural Advisory Council must reflect the diversity of the Greater Louisville community with special attention paid to those who have been historically underrepresented based on race/ethnicity, age, disability, sexual orientation, gender, gender identity, socioeconomic status, geography, citizenship status, or religion.

Members of the Cultural Advisory Council should also represent a diversity of artistic disciplines and size of organization.

### **Who Leads the Cultural Advisory Council?**

The Cultural Advisory Council is led by two co-chairs: 1) a member of the Fund for the Arts Community Impact Committee and 2) a member of the Cultural Advisory Council elected by his/her peers on the Council.

The Cultural Advisory Council co-chair is invited to serve as an ex-officio member of the Fund for the Arts Board.

The Cultural Advisory Council co-chair's term is for two years.

## Call for Nominations

### **What is the Time Commitment?**

The Cultural Advisory Council will meet up to three times per year.

### **How do I submit a Nomination?**

Cultural Advisory Council members are nominated by their peers or are self-nominated to serve a two-year term. Membership on the Council may be renewed once.

Nominations and final selections to the Cultural Advisory Council are considered by the Fund for the Arts Community Impact Committee.
